1. Counsellor/Coach

- YC Tse is a registered Counsellor and Coach of Nederlandse Federatie Gezondheidszorg NFG (OTR No.9663); a registered coach of LVSC (Landelijke Vereniging voor Supervisie En Coaching)) in the Netherlands (Reg No. TSE -RC001); a Graduate Member of Human Givens Institute in the United Kingdom (Membership No. 187659).
- I am currently working towards my full accreditation as a Human Givens practitioner in the United Kingdom.

2. Pricing

- The tariffs are indicated on the website www.your-lifestory.com at the webpage/Meet Antony
- The session is charged per hour basis, unless otherwise agreed with clients.

3. Cancellation / Missed Session Policy

• If you cancel the schedule session before 48 hours notice, cancellation will be free of charge and can be rescheduled without cost. For cancellations made after this time, or a session with no-show, full session rate will be charged.

4. Frequency of session

Appointments will be arranged based on client's and counsellor's availability. Each client's
journey is different. These can normally be fixed at weekly, bi-weekly, or at different
frequencies upon agreement with clients.

5. Invoicing and payment

- Each session is billed at the end of every week, unless otherwise arranged.
- Invoice will be sent via client's email address, unless otherwise arranged.
- Invoice is to be settled within 7 days from the invoiced date.
- Payment is to be made via bank transfer in EURO to the designated bank account as indicated in the invoice.

6. Medical insurance

• I am currently not affiliated with any insurance companies. Although your session fees cannot be reclaimed via your insurance package, working with independent mental health practitioner gives you much greater flexibility and freedom in meeting your specific health

- care needs. You don't need to receive a specific mental health diagnosis or being confined to a specific treatment plan as indicated by the insurance companies, if any.
- Please note I also do not prescribe any medication.

7. Confidentiality

- I keep the content of our sessions confidential and it is important that you feel this is a private space and you are as free as possible to talk about your thoughts and feelings.
- There are however some limits to the confidentiality:
 - There are legal limits to confidentiality around disclosure of committing or intent to commit criminal offences; domestic violence; suicidal attempts or based on Child Protection Acts.
 - I work with my counselling/coaching supervisor on a regular basis to monitor and to improve my work undertaken. All supervision is done on a anonymous and confidential basis.
 - At times I may need to contact client's GP or other professional involved. This would be done with the client's permission and would be discussed in the session prior to any contact. However, if the client's or another person's safety were severely jeopardised in the counsellor's view, I may contact the external services without the client's permission.
- I ask that you do not share our discussions on any social media.

8. Online session

 Should client choose to have online sessions, sessions will be hold via Zoom platform with encrypted end-to-end protection. All our conversations will remain private and will not be recorded.

9. Process

- First consultation is 30 mins (no charge) and will be held via phone/Zoom. The consultation is for you to get more ideas on my approach and how we could work together in your journey. It is also for me to understand how I can be of help for you.
- After the consultation I will propose a plan on the areas to work on together for you to consider. Should you accept the proposal we will start the first session and throughout the progress you will be able to make adjustment to best fit your needs.

10. Ethics and Professional Practice:

1. Counsellor/Coach 輔導員/ Coach

本人目前正在邁向獲得英國 Human Givens 輔導/心理治療從業員的全面認證。

2. 收費

除非與客戶另有協議, 面談將會按每小時收費。收費詳情請參閱網站 www.your-lifestory.com 上的個人簡介網頁。

3. 取消預約細則

 如果客戶於48小時前通知取消預約面談,取消手續將會免費,並且可以免費重新安排 面談時間。客戶若於此時間之後取消或未有出現面談,有關費用將全額收取。

4. 面談次數

 面談次數安排將視乎客人和輔導員的時間而定。每個客人的人生旅程都不一樣,故此 面談次數因人而定。通常可以每週、每兩週或以其他安排進行。

5. 發票與付款

6. 醫療保險

8. 在線面談

如果客戶選擇在線面談,面談將通過具有加密端到端保護的 Zoom 平台進行。我們所有的談話內容將會保密,不會被錄音。

9. 過程

- 首次諮詢(半小時)是不收費用,透過網上 Zoom 或電話進行。一方面讓本人明白您的處境及期望,另一方面也讓您了解本人的輔導方法以及將會如何為您提供適切的幫助。
- 首次諮詢後,本人會提供一份建議計劃書,供您參考。若您願意接受該計劃書,我們將開始安排首次傾談。在整個過程中,我們將會定期回顧進度,調整及配合您最適切的需要。
